General information about the research study and collected research data

You are invited to take part in a study which explores how the existing incubators and accelerators are supporting the development of sustainable enterprise (especially through online engagement with entrepreneurs), and the challenges and opportunities they face. Your contribution to the study will help us to reflect upon the feasibility to develop an online incubator/accelerator at The Open University and assess the extent to which OU enterprise and innovation students aspire to start their own businesses and/or grow their existing enterprises; as well as understand the nature and scale of support they would need to materialise their aspirations. This research will be carried out by Dr Sara Calvo, Dr Francesca Calo, Dr Aqueel Wahga and Dr Michael Ngoasong at the Faculty of Business and Law, The Open University. This project has been reviewed by, and received a favourable opinion from, The Open University Human Research Ethics Committee, reference 4595.

Before you decide whether or not to take part in this study, it is important that you understand what participation in the study will involve and how the information collected will be used. Please note that the interview is only open to people over the age of 18.

What will I be asked to do if I agree to take part?

If you are interested in taking part in the research study, you will be asked to participate in an interview, and it will last between 45-60 minutes duration. Before the start of the interview, you will be asked to complete a consent form.

It is your decision as to whether to take part. If you decide to take part, you can withdraw from the interview at any time, without giving a reason.

We cannot promise that the study will help you personally. However, the results should help our understanding of how incubator and accelerator programs work at other institutions and explore the feasibility of setting up a virtual incubator and accelerator that can support OU students in the Innovation and Enterprise pathway in improving their employability and enhancing their entrepreneurial journey.

There are no right or wrong answers to the interview. We are genuinely interested in hearing about your perspectives and experiences. If at any point in the interview you feel uncomfortable, you can stop the process at any time and you do not need to continue the interview.

How will the data I provide be used and privacy be maintained?

All of your information will be handled in confidence. Data will be kept secure in a protected passworded folder on an Open University server. Personal data will be kept until the data collected is anonymised (approximately one month after the completion of the interview). Once anonymised, personal data is destroyed. Anonymised research data will be kept for seven years.

Your personal details will not appear in any documents or in the final report. Your rights are protected under the General Data Protection Regulation. Any information that might identify you will not be shared outside the research team. No identifying information will appear in any documents or in the final report. Anonymity will be provided in case of verbatim extracts (quotations).

Data Protection
